B Com (Honours) Programme

Students, who have maintained a CGPA of 8.0 and above and have completed all curricular requirements up to Semester 3, may register for the B.Com (Honours) program at the commencement of Semester 4.

The **B.Com (Honours) programme** requires 3 additional '**Honours Electives**' and the completion of a term paper / project under the supervision of a Faculty Guide for 4 credits. The total credits of the B.Com (Honours) Program would be 147 over 6 semesters. The Honours Electives and the Term Paper / Project must be chosen in a coherent way related to a single area. This will enable them to get a Micro Specialization Certificate.

At present, the following areas have been identified for 'Honours Electives' and 'Micro Specialization':

1. **Strategic Management:** The kinds of elective courses that would be offered under this head will be decided later
Or
2. **Financial Economics:** The kinds of elective courses that would be offered under this head will be decided later
Or
3. **Artificial Intelligence and Data Sciences:** The kinds of elective courses that would be offered under this head will be decided later and the same would be offered by the School of Engineering

Note: B. Com (Honours) students are expected to maintain a CGPA of 8.0 and above throughout the programme.
